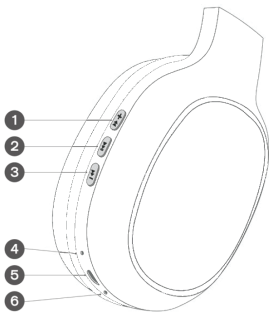

Entering SIRI (Apple devices) assist: Press and hold  for 1.5 seconds

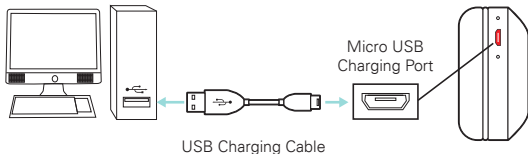
Volume control: Press and hold  or

# Getting Started

## Charging the Headphones

Plug the small connector of the included Micro USB charging cable into the charging port on the Headphones. Plug the other connector into a USB power source, such as a USB port on a computer, or into a **5V USB adapter** (not included) and plug into an electrical outlet.





When the battery level is low, you will hear the voice prompt "Battery low".

## LED Light status


1. Charging status: Long bright red light, full charged red light was off.
2. Device on prompt: Blue light on
3. Pairing status: Red and blue LED flash alternately
5. Standby status: Blue light flash
6. Already connected status: Long bright blue light
7. Play status: Blue light bright 1 second and flash 1 time.

## Powering ON/OFF

- Turning on: Press and hold  for 2 seconds, you will hear the prompt “Power on”
- Turning off: Press and hold  for 2 seconds, you will hear the prompt “Power off”


**Note:** The headphones will automatically power off if they are not paired to a Bluetooth device after 3 minutes.

## Bluetooth Pairing

- First time pairing
  1. Enter the pairing mode automatically, and you will hear the voice prompt “The Bluetooth device is ready to pair”.
  2. Go to the Bluetooth settings on your device and select “ARBT102”.
  3. After the success of the matching Prompt, you will hear the voice prompt “The Bluetooth device is connected successfully”.
- Re-pairing: Under off status, press and hold  about 2 second, red and blue LED flash alternately.

## Re-Pairing the headphones

The ARBT102 headphones should pair to each other automatically when powered on. If the headphones come un-paired from your device, try following these instructions to re-pair:

1. Go to the Bluetooth settings on your device, and tap the  on “ARBT102”: Tap to manually **“Forget”** the device, then turn off the headphones.
2. Turn the headphones back on again.
3. Follow the instructions in the **Bluetooth Pairing** section of this manual to try pairing again.
