Using the Massager

- Press and hold the **[Power]** button to power the massager on. Heat will be enabled and the LED indicator will **turn RED**.
- Press the **[Power]** button to disable heat and enable vibration. The LED indicator will **turn BLUE**.
- Press the **[Power]** button again to enable low vibration. The LED indicator will **turn GREEN**.
- Press and hold the **[Power]** button again to power off.
- The massager will shut off after 45 minutes of use.
