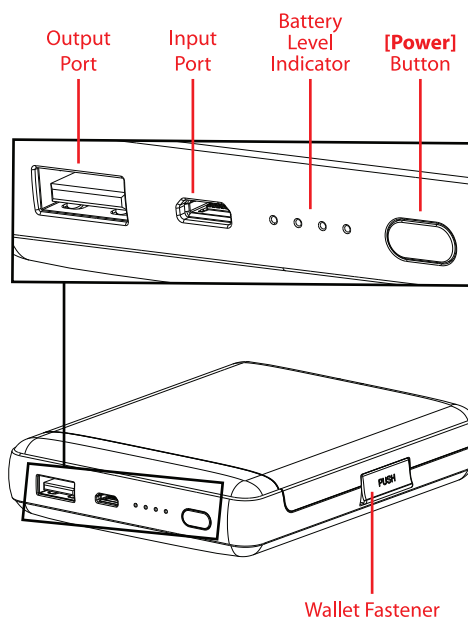

## Getting Started

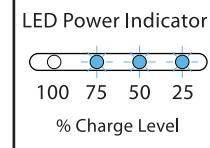
### Using the Wallet

- To open, press the bottom of the Wallet Fastener and pull up on the wallet cover.
- To close, press the cover closed.

### Charging the Wallet

Plug the small connector of the included USB cable into the wallet's Input Port. Plug the large connector into the USB port on a computer, or a **5V USB adapter** (not included).

The Battery Level Indicator will blink while charging, showing the current level of charge. (4 parts lit indicates 100% charge, 3 parts indicates 75% charge, and so on).



### Charging Your Device

Plug the large connector of your device's USB cable into the wallet's Output Port. Plug the small connector into the charging port on your device. Your device should begin charging.

As your device charges, the Battery Level Indicator will display the remaining level of charge.
