



## Light Up Rechargeable Baseball CPTN1000

### READ CAREFULLY AND KEEP THIS CARD

#### Important Safety Warnings

- This product is not recommended for those without experience in throwing/catching baseball or softball.
- Adults must be present when children use the product to ensure correct usage and prevent danger.
- To ensure safety, **only** throw the product at speeds appropriate for the reaction time of participants.
- Make sure that the Cipton ball is glowing correctly before throwing.
- Be aware of the safety of the surrounding environment to prevent danger.
- Do not stare at the LED light for any extended period of time or at close distance.
- Place this product and its components beyond the reach of children.
- Do NOT attempt to disassemble, alter or repair the product yourself.
- Discontinuation of battery power during "play and catch" poses a physical hazard.
- The Cipton ball is for the game of catch only and cannot be hit with a baseball bat, or it may be damaged.
- The Cipton ball can withstand speeds of up to 140 km/h pitching in gloves. It may be damaged beyond this speed.
- The surface of the Cipton ball is genuine cowhide leather. Impact on concrete surfaces and contact with water accelerates the wear of the ball.
- Do not use equipment in location where play & catch is restricted or prohibited, as this may lead to disasters or accidents.
- Do not submerge in water.
- Keep away from extreme temperatures.
- Adult supervision is required.
- The device comes with a built-in battery which should not be disposed of with regular household waste. Follow all local laws and regulations in disposing of batteries.

#### Charging the Baseball

1. Lift up the silicone cover over the power port on the baseball, and plug the small connector of the included USB Type-C power cable into the power port.
2. Plug the large connector into the USB port on a computer, or into a **5V/1A USB adapter** (not included) and plug into a wall socket.
3. The baseball's LED lights will breathe GREEN while the baseball is charging.

#### Using the Baseball

##### **Charge the baseball fully before use.**

- Press the [ ⏻ ] button on the baseball to power the LED lights ON.
- Press the [ ⏻ ] button additional times to change colors.
- Press + hold the [ ⏻ ] button for **5 seconds** to turn the LED lights OFF.
