In the Box

- Himalayan Crystal Rock Lamp Shade
- Wired Base w/Bulb (15W C7 E12 incandescent bulb)

Caution: The item may be heavy and can cause damage if dropped, *please handle with two hands*. Do NOT place the lamp near the edge of surfaces as it might tip and fall over. Do NOT place the lamp on weak, broken or unsteady surface.

Setup

Remove the item from its packaging and place on a **flat, sturdy** surface. The lamp already has a bulb installed, plug the lamp in.

Replacing the Bulb

Turn off, unplug and carefully turn the salt rock lamp upside down. Gently pull and remove the wired base from the salt rock lamp shade.

Unscrew the bulb and replace with a new **15W C7 E12** or **E14** incandescent bulb.

Once the bulb is replaced, gently slide the base back into the lamp shade.

Using the Lamp

- To turn the light **ON/OFF**, turn the dial on the lamp's power cable until it "clicks" on.
- The light level can be adjusted with the dial.
