When not using the lamp, it is recommended that it is stored away in a safe location, away from sources of water or heat and free of dust and debris.

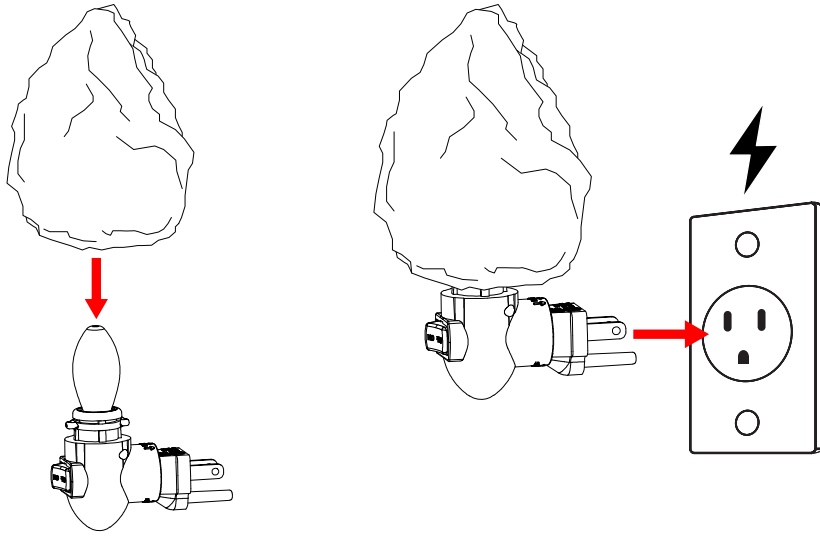
If the salt shade is dirty, wipe it down with a **clean microfiber cloth**. Do not clean with water or any sort of cleaning liquid or detergent.



**Do not use any soap, detergent, or bleach to clean**

## Using the Lamp

Remove any protective film or seal from the salt shade. Carefully place the shade over the light bulb of the night light. Insert the night light into an electrical outlet.



Press the **[Power]** switch on the night light to power ON and OFF.

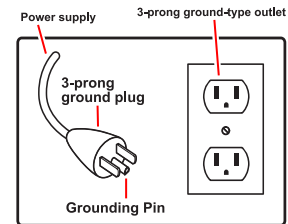
