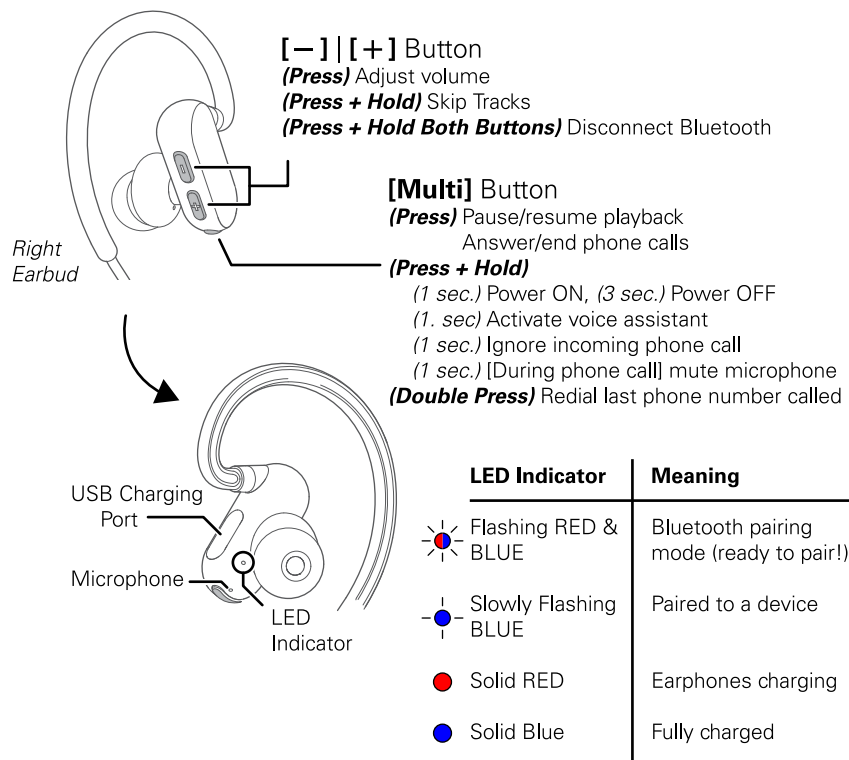

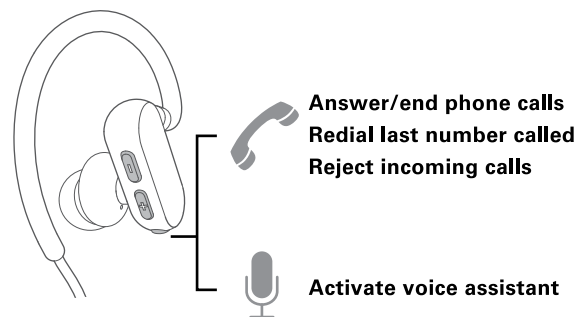
Phone Calls

- Press the **[Multi]** button to answer an incoming phone call or to end a call.
- Press and hold the **[Multi]** button for 1 second to reject an incoming phone call. It will be sent straight to voice mail.
- Double press the **[Multi]** button to redial the last phone number called.
- While talking, press and hold the **[Multi]** button for 1 second to mute the microphone on the earphones.

Activate Voice Assistant

- Press and hold the **[Multi]** button for 1 second to activate your device's voice assistant function.

Note: You must have a phone with a voice assistant installed and/or activated. Please consult your phone's user manual for more details.



Playing Music

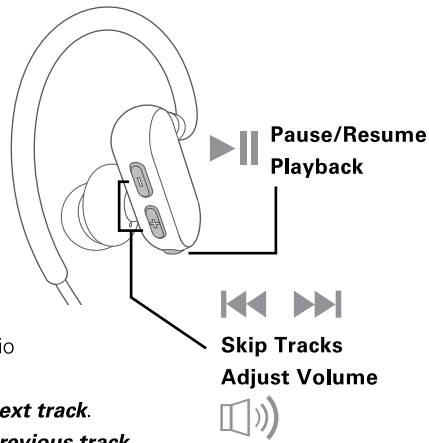
Make sure that the earphones are fully charged before using. Power the earphones on and connect to a Bluetooth-enabled device (refer to the **Bluetooth Pairing** section on page 7).

Adjusting Volume

- Press the [+] button to **increase** volume.
- Press the [-] button to **decrease** volume.

Controlling playback

- Press the [Multi] button to pause/resume audio playback.
- Press and hold the [+] button to skip to the **next track**.
- Press and hold the [-] button to skip to the **previous track**.

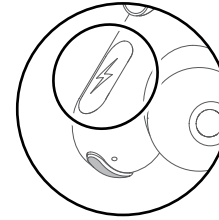


Charging the Earphones

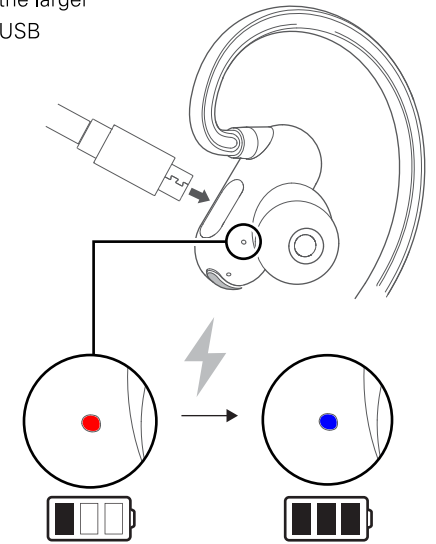
Undo the rubber protective seal from the USB charging port.

Insert the small connector of the supplied micro-USB charging cable into the USB charging input on the side of the right earbud. Insert the larger connector into the USB port on a computer, USB charging device, or a **5V/1A USB adapter** (not included) and plug into an electrical outlet.

The LED indicator will **turn RED** while charging and **turn BLUE** when fully charged.



When done charging, make sure the rubber protective seal is pressed back into place.

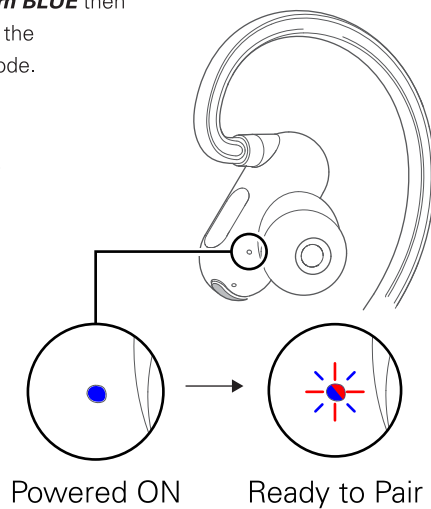


Power On/Off

- Press and hold the [Multi] button for 1 seconds on the right earbud to power on. A tone will be heard and the LED indicator will briefly **turn BLUE** then begin to **flash RED and BLUE** indicating that the earphones have entered Bluetooth pairing mode.

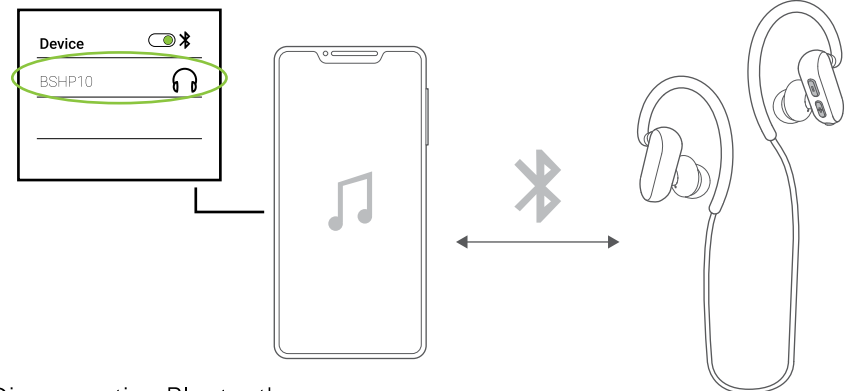
- If the earphones have been previously paired to a device, it will automatically re-pair to that device if the device is powered ON, within Bluetooth range, and has Bluetooth enabled.

- Press and hold the [Multi] button for 3 sec. to power off. The LED indicator will briefly **turn RED** then the earphones will power off.



Bluetooth Pairing

1. Power the earphones ON. A tone will be heard and the LED indicator will **flash RED and BLUE**.
2. Open your device's Bluetooth menu and tap **BSHP10**.
3. Another tone will be heard, indicating that the earphones are successfully connected to your device, and the LED indicator will **slowly flash BLUE**.



Disconnecting Bluetooth (Resetting the Earphones)

To reset the earphones and disconnect from any Bluetooth connection, press and hold the [+] and [-] buttons at the same time for 4 seconds. A tone will be heard and the earphones will enter Bluetooth pairing mode. The LED indicator will **flash RED and BLUE**.
