

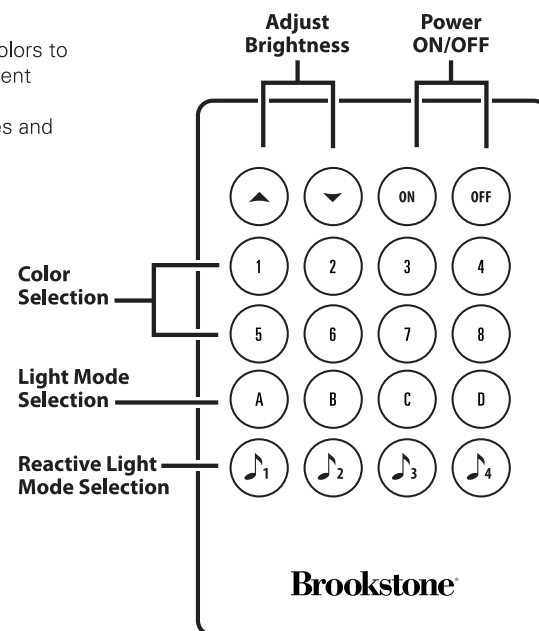

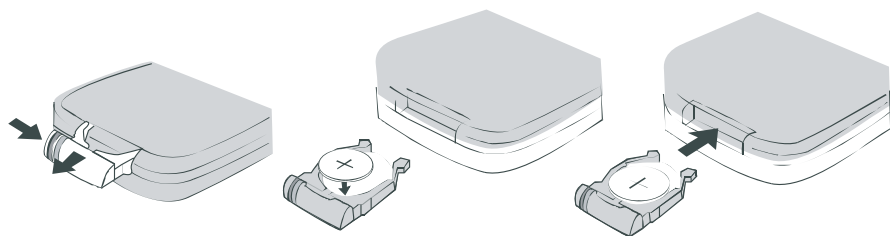
## Using the Remote Control

- Adjust Light Level**  
Use the [  ] and [  ] buttons to adjust the brightness of the LED strip light
- Power ON/OFF**  
Power the light ON/OFF
- Select Colors**  
Select from up to 8 different colors to perfectly match your environment
- Select Light Mode**  
Select from up to 4 light modes and 4 sound-reactive light modes



## Replacing the Remote Control Batteries

To replace or install the remote control battery, push and slide the battery door out from the remote control. Replace the battery with a new CR2025 battery with the positive (+) polarity facing up.



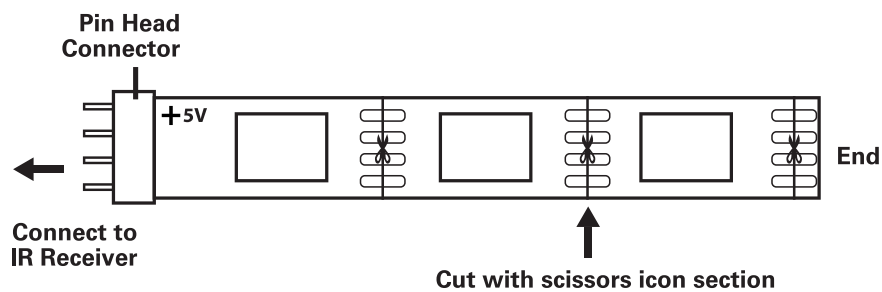
## Using the LED Lights

## Trimming the LED Strip

The LED strip can be cut to an appropriate size, however **once it is cut, the piece that has been cut off will NOT be usable**. Please be absolutely sure that the section you are cutting will not need to be used.

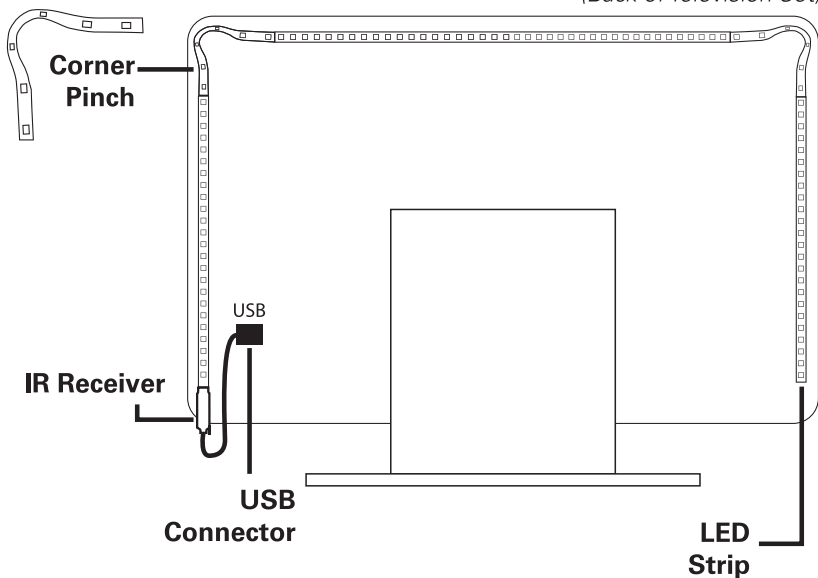


Using a pair of scissors, carefully clip along the dotted cut line of the LED strip. Do NOT sever or cut the copper contacts on either side of the dotted cut line.

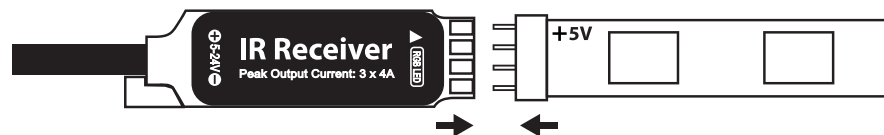
## Installation

Once you have determined exactly how you want to set up the LED strip light, it can be installed. Make sure that the strip is placed close enough to a power source before placing onto a surface.

1. Clean the surface of the area you plan on placing the strip light.
2. Remove the 3M backing and gently place then press onto the desired location.
3. Plug the USB power cable into a USB port on your TV or into a 5V/1A USB adapter (*not included*) and plug into a wall outlet.

**The sticker and +5V should be on the same side when connected**

For optimal performance, place the IR receiver in a location away from the IR receiver of your TV or other system with an IR receiver to avoid interference between the two.
