
- · This product is NOT a toy, keep away from children and pets.

# Using the UV Nail Dryer

### Location of Controls



### Using the Nail Lamp

- 1. Place the nail lamp on a flat, solid, stable surface.
- Plug the attached USB power connector into a USB power source, such as the USB port on a computer, or a 5V USB wall adapter (not included).
- 3. After painting nails, place hand or foot into the opening of the nail lamp, with the nails facing up.
- 4. Press one of the timer buttons on the top of the nail lamp. Choose between 30, 60 or 90 seconds.

### ▲ Important Safety Instructions

- Never look directly into the UV light.
- · Do not overexpose nails or skin to UV light.
- Do not use with gels that are not formulated to cure in LED light. This can cause chemical burns.
- Do not use if you have sunburn, easily burned skin, or any open wound or infection
- · Do not use if you have previously had skin cancer.

# Using the Electric Nail File

### Nail File Heads



Reach edges, remove cuticles & dead skin



Trim & file down nails initially



Exfoliate & file

For final polishing

### Installing Batteries

- 1. Pull down on the battery compartment cover on the back of the nail filer handle to remove the cover.
- Install 2 AA-sized batteries (not included) into the battery compartment, following the polarity (+/-) diagram on the inside of the compartment. Make sure the batteries snap into place.
- 3. Slide the cover back on, and push until it clicks closed.

# Installing a Nail File Head

 To install a nail file head, alignthe bottom of the nail file head with the mount at the top of the nail filer. Press into place.

 To remove a nail file head, grip firmly and pull off.

# Using the Nail Filer

Install batteries, and install the desired nail file head.

Move the Power Dial on the nail filer handle to select a direction and speed, as shown at right.
