Charging the Eyelash Curler

Plug the small connector of the included micro-USB charging cable into the micro-USB charging port on the bottom of the eyelash

Plug the large connector into a USB power source, such as the USB port on a computer, or a 5V/1A USB wall adapter (not

Powering ON/OFF & Adjusting Temperature • Press + hold the Power button

on the eyelash curler for 3 **seconds** to power ON. The eyelash curler will power ON on the lowest temperature setting (60 °C / 140 °F), and the green LED indicator will light up.



- . Short press the Power button to switch to the medium temperature setting (60 °C / 154 °F). The orange LED indicator will
- Short press the Power button a 2nd time to switch to the high temperature setting (80 °C / 176 °F). The red LED indicator will light up.
- Press + hold the Power button on the eyelash curler for 3

Using the Eyelash Curler

- 1. Power the eyelash curler ON, and select a temperature setting.
- Wait 5 minutes for the eyelash curler to heat up fully. 3. Carefully, use the heated brush
 - head to brush your eyelashes in the desired direction.



Warning: use the heated brush VERY CAREFULLY, as misuse can burn the eyes. Contact doctor immediately if injury occurs.

- 4. You may apply mascara either before or after using, if desired.
- 5. When finished using, power curler OFF, and allow to cool completely before storing away.
