Place scent pad onto the platform on the top of the lamp base.</p> 	<h3 style="text-align: center;">Setting Up</h3> <p>Place the salt bowl onto the lamp base. One by one, carefully place the included Himalayan pink salt into the salt bowl.</p>  <p>Connecting to Power Plug the small connector of the included USB power cable into the power port on the side of the air freshener. Plug the large connector into a USB power port, or into a compatible 5V USB adapter and plug into a wall socket.</p>  <p>Powering ON/OFF</p> <ul style="list-style-type: none"> • Connect to power. The air freshener fan and the LED light will automatically power ON, and the lights will cycle through different colors. • Disconnect from power to turn the speaker and lights OFF.
