





<h3>Precautions & Warnings</h3> <ol style="list-style-type: none"> Do not fill over MAX level line. Do not turn the aroma function on when the tank is empty. Do not touch the inside base of the tank. Clean regularly per the instructions in this user manual to avoid malfunctions. Always unplug from power source before maintenance. Always pour any remaining oil out of the tank and wipe with a clean, dry cloth. Essential oils can stain. In the event of a spill or leakage, please wipe away any water or oil with a soft cloth. Do not let aroma blow directly onto furniture, clothing, art, or any valuable objects. Keep away from direct sunlight, heat sources, air conditioners, and fans. Always keep on a stable, flat surface. Do NOT place on a carpet, bed, cushion or other non-flat, non-stable surface. Keep away from electronic equipment. Do not tip the product as it may cause water to enter the mechanism and cause malfunction. Do not use for more than 6 hours at a time. Never move the product while in use. Do not touch any part of the product with wet hands. Keep out of reach of children and pets. Children should not be left unsupervised near this product. This unit is not to be used by children or any person(s) with reduced physical, sensory, or mental capabilities, or lack of experience and knowledge, unless they have been given express supervision and instruction. Do not expose the unit to extreme temperatures (heat or cold), open flames, humid conditions, or wet conditions. Do not submerge in water. Do not open this product or attempt to repair the unit yourself should it not be working. The amount and intensity of aroma produced will vary. Factors that affect production of aroma can include water type, humidity, temperature, air current, and/or type or brand of essential oil used. It may take up to a half hour before you can smell the essential oil. Aroma Operation Time: Up to 8 hours Water Tank Capacity: 100 mL The suggested room size for this device is ~150 ft² (this may vary greatly by environment, type of essential oil used, etc.). Only 100% natural essential oil should be used with this product. Oil containing chemical fragrance, spice, or other impurities may cause malfunctions. ONLY use the supplied power cable. If using a USB adapter, it MUST be a 5V/1A USB adapter (not included). When not in use, the diffuser should be stored in a dry, cool location, away from sources of water or heat. Plug into a USB adapter or other USB power source (not included). Remove the cover and inner lid and fill the tank with room temperature water until the MAX level line is reached. Add 2 - 3 drops (~0.1 - 0.15 mL) of essential oil. Replace the inner lid and cover and place on a flat, sturdy surface. <p>CAUTION: Using more than the recommended amount of oil may cause the diffuser to get clogged and not operate properly.</p>	<h3>Using the Diffuser</h3> <ul style="list-style-type: none"> Press the [Mist] button to turn the diffuser on. The LED lights will turn on and fade through colors. Press a second time to turn the lights off. Press a third time to turn the diffuser off. If there is no water in the tank, the diffuser will automatically shut off. <p>Using the Timer</p> <ul style="list-style-type: none"> Press the [Timer] button to set a diffuser timer for 1, 2 or 3 hours. <p>1st Press - 1 hour of diffusion 2nd Press - 2 hours of diffusion 3rd Press - 3 hours of diffusion 4th Press - Timer off</p> <p>Cleaning the Diffuser When you are finished using the diffuser, unplug the cable, and drain any water remaining in the tank.</p> <p>Gently wipe the inside of the tank with a clean cloth or rag to remove any leftover oil. Do NOT use any soaps or detergents to clean the water tank.</p> <p>Carefully clean the nozzle over the ultrasonic pad with a brush or cotton swab.</p> <p>Do not use any soap, detergent, or bleach to clean</p>
