


Setting Up

Setting Up (Cont'd)

Set up the sanitizer & connect to power. Open the cover of the sanitizer from the front, and place the device you would like to clean inside of the sanitizer. Close the lid.






Using the UV Sanitizer

The UV sanitizer has two sanitization modes: Fast Sanitize mode and Deep Sanitize mode.

- Press the [Power] button once (1x) to Fast Sanitize
- Press the [Power] button twice (2x) to Deep Sanitize.
- . When Fast Sanitize mode is activated, the LED indicator on the lid of the sanitizer will **turn BLUE**, and the sanitizer will sterilize for the next **90 seconds**. When it is finished, the LED indicator will flash BLUE 3 times then will turn off.

 When **Deep Sanitize** mode is activated, the LED indicator on the lid of the sanitizer will **turn GREEN**, and the sanitizer
- will sterilize for the next $\bf 5$ minutes. When it is finished, the LED indicator will flash GREEN 3 times then will turn off.



Once the UV sanitizer is completely finished sanitizing, open the lid, flip your device over, and repeat the sanitization again for other side of your device.

Caution: This device is designed to limit human & animal exposure to UV-C light, as it is harmful to skin and eyes. This device is equipped with a safety feature that automatically shuts the UV-C light OFF when the lid is opened.
