









Please consult the local authorities on the correct way to dispose of this device.</li> </ul>	<h3 style="text-align: center;">Location of Controls</h3> <p><b>UV-C Sanitizer 2x Toothbrush Holder</b></p>  <p><b>Installing the Holder</b></p> <ol style="list-style-type: none"> <li>1. Choose a smooth, non-porous wall or surface on which to mount the toothbrush holder. Be sure about the location choice, as the adhesive tape can only be used once.</li> <li>2. Peel the backing off the adhesive tape on the back of the magnetic piece, and place the adhesive side on the desired surface. Firmly press against the surface for at least 1 minute. Let set for several more minutes.</li> <li>3. Once the magnetic piece is mounted to the wall, it can hold the toothbrush holder with the built-in magnets. Simply pull to remove the toothbrush holder from the wall.</li> </ol>	<h3 style="text-align: center;">Charging the UV-C Sanitizer</h3> <p>Plug the small connector of the included charging cable into the micro-USB charging port on the back of the toothbrush sanitizer.</p>  <p><b>Back of Holder</b></p> <p>Plug the large connector into a USB power source, such as the USB port on a computer or into an compatible <b>5V USB adapter (not included)</b> and plug into a wall socket.</p> <p>The LED indicator on the top of the sanitizer will <b>turn RED</b> when charging and turn <b>OFF</b> when fully charged.</p> <p><b>Low Battery Warning:</b> The LED indicator will flash <b>BLUE</b> when the sanitizer is low on battery. Please recharge to use again.</p> <h3 style="text-align: center;">Using the UV Sanitizer</h3> <ol style="list-style-type: none"> <li>1. Open the lid of the sanitizer and place the toothbrush head into the UV-C sanitizer <b>with the toothbrush head facing down</b>. The toothbrush body will stick out of the sanitizer through the toothbrush opening in the front of the sanitizer.</li> <li>2. The sanitizer will automatically begin sanitizing when the case lid is closed. The LED indicator on the top of the sanitizer will <b>turn BLUE</b>, and the sanitizer will sterilize for the next <b>90 seconds</b>. When it is finished, the LED indicator will flash <b>BLUE</b> 3 times then will turn <b>OFF</b>.</li> <li>3. Once the sanitizer has completely finished sanitizing, you may open the case and remove your toothbrush. For extra deep cleaning, sanitize a second time.</li> </ol>  <p><b>CAUTION:</b> This device is designed to limit human &amp; animal exposure to UV-C light, as it is harmful to skin and eyes. This device is equipped with a safety feature that automatically shuts the UV-C light <b>OFF</b> when the lid is opened.</p>
