

▲ Important Safety Instructions

- This product is NOT a toy, keep away from children and pets.
- Only use the device according to the instructions in this manual. Never use the device for anything other than its intended purpose.
- This device is NOT a substitute for proper medical equipment or attention.
- ONLY use the supplied power cable.
- Do not open this product or attempt to repair the unit yourself should it not be working. Doing so risks fire, shock or injury.
- The device contains an safety feature that powers it off automatically when the cover is opened. Do NOT disable this safety feature. Never allow UV-C light to shine in eves or on skin.
- When not in use, the device should be stored in a dry, cool location, away from sources of water or heat.
- It is recommended that the device be covered to protect it from exposure to dust if it will not be in use for a long period of time.
- Do not expose device or power cable to extreme temperatures (heat or cold), open flames, humid or wet conditions.
 - Do not submerge in water. Do not use in a location where the device or power cable could fall into liquid.
 - · Unplug the power cable when not in use.
- Do not pull the power cable to disconnect, or use the cable as a handle.
- Do not use if device or power cable is damaged. If device or power cable is damaged, it MUST be serviced or replaced by the manufacturer or its service agent before using again.
- The device contains a built-in battery and should not be disposed of with regular household waste. Please consult the local authorities on the correct way to dispose of this device.

Location of Controls




Undo the protective cover, and plug the small connector of the included USB charging cable into the charging port on the front of the sanitizing bag.

Plug the large connector into a USB power source such as the USB port on a computer, or a 5V/0.4A USB adapter (not included) and plug into a wall outlet.


The LED indicator will

turn RED while the bag is charging, and turn OFF when the bag is fully charged.



Setting Up

Charge the battery fully before using. Unzip the bag, and open the lid. Place the device you would like to sanitize inside of the sanitizer. Close the lid, and **zip closed completely**.



Using the UV Sanitizing Bag

The $\overrightarrow{\text{UV}}$ sanitizer has two sanitization modes: Fast Sanitize mode and Long Sanitize mode.

- Press the [Power] button once (1x) to Fast Sanitize
- Press the [Power] button twice (2x) to Long Sanitize.
- When Fast Sanitize mode is activated, the LED indicator on the lid of the sanitizer will turn BLUE, and the sanitizer will operate for the next 5 minutes. When it is finished, the LED indicator will flash BLUE 3 times then will turn off.
- When Long Sanitize mode is activated, the LED indicator on the lid of the sanitizer will turn GREEN, and the sanitizer will operate for the next 10 minutes. When it is finished, the LED indicator will flash GREEN 3 times then will turn off.
- Once the UV sanitizer is completely finished sanitizing, open the lid, flip your device over, and repeat the sanitization again for other side of your device

Caution: This device is designed to limit human & animal exposure to UV-C light, as it is harmful to skin and eyes. This device is equipped with a safety feature that automatically shuts the UV-C light OFF when the bag is not completely zipped. Never defeat this feature or expose skin or eyes to UV-C lights.


