


# Getting Started


## Location of Controls



## Connecting to Power

Insert the small connector of the included USB power cable into the power input port on the back of the clock. Insert the large connector into the USB port on a computer or into a compatible **5V/2A USB Power Adapter** (*not included*) and plug into a wall outlet.

The clock display will turn on when the clock is connected to power.



If the clock is disconnected from power, it will only save the time and settings for 60 seconds.

## Display Modes

Press the **[UP]** button on the back of the clock to switch between clock display modes. Press the **[SET]** button to save as the default mode.

- **Mode 1** shows the time for 10 seconds and the date and temperature for 2 seconds.
- **Mode 2** shows the time, alarm, date and temp. at all times.

## Setting the Time

1. Press the **[SET]** button until the time is displayed.
2. *Press + hold* the **[SET]** button to set the time. The time hours will begin flashing. Press the **[UP]** and **[DOWN]** buttons to adjust. The rectangle in the lower left corner of the display will light up **WHITE** when the hour is in PM.



3. Press **[SET]** to save the hour setting. The minute digits will begin flashing. Press the **[UP]** and **[DOWN]** buttons to adjust, and press **[SET]** to save. The clock will return to its default display mode.

## Setting the Alarm Time

1. Press the **[SET]** button until the alarm time is displayed.
2. Press the **[DOWN]** button to turn the alarm ON or OFF. The rectangle in the upper left corner of the clock display will light up WHITE when the alarm is turned on.

3. When the alarm is turned on, *press + hold* the **[SET]** button to set the alarm time. The alarm hours will begin flashing. Press the **[UP]** and **[DOWN]** buttons to adjust.
4. Press **[SET]** to save the alarm hour setting. The alarm minute digits will begin flashing. Press the **[UP]** and **[DOWN]** buttons to adjust, and press **[SET]** to save. The clock will return to its default display mode.

## Setting the Date

1. Press the **[SET]** button until the date is displayed.
2. *Press + hold* the **[SET]** button to set the date. The year will begin flashing. Press the **[UP]** and **[DOWN]** buttons to adjust.
3. Press **[SET]** to save the year setting. The month will begin flashing. Press the **[UP]** and **[DOWN]** buttons to adjust, and press **[SET]** to save the month.
4. The day will begin flashing. Press the **[UP]** and **[DOWN]** buttons to adjust, and press **[SET]** to save. The clock will return to default display mode.

## Changing Temperature Units

1. Press the **[SET]** button until the temperature is displayed.
2. Press the **[DOWN]** button to switch between degrees Fahrenheit ( $^{\circ}$  F) and Celcius ( $^{\circ}$  C).
3. Press **[SET]** to save. The clock will return to default display mode.

## Using the Bedside Light

- Press the **[SNOOZE/LIGHT]** button on the top of the clock to turn the bedside light ON in white light mode.
- Press the **[SNOOZE/LIGHT]** button to adjust the light brightness between low, medium and high.
- *Press and hold* the **[SNOOZE/LIGHT]** button to switch to color-changing light mode.
- In color-changing light mode, press the **[SNOOZE/LIGHT]** button to choose a light color.
- *Press and hold* the **[SNOOZE/LIGHT]** button to switch back to white light mode. **Note:** the bedside can only be powered OFF from white light mode.

**Note:** The bedside light cannot be used when the clock is in sunrise mode and snooze mode.

## Using the Sunrise Light

The clock's sunrise light function will turn on 20 minutes before your alarm time, and gradually increase in brightness until your alarm goes off.

To use the sunrise light, set the alarm before you go to sleep.

## Snooze Function

- Press the **[SNOOZE/LIGHT]** button when the alarm goes off to activate the Snooze function. The alarm will ring again in 5 minutes. The sunrise light will continue to shine at full brightness during the snooze time.
- To turn the alarm and sunrise light off completely, press and hold the **[SNOOZE/LIGHT]** button when the alarm goes off. This only turns them off for the day, and they will activate again as normal the next day.

## Using the USB Power Output

You can power or charge a USB device using the USB power output port on the back of the clock.

To use, simply plug your device's USB connector into the USB power port while the clock is connected to power.
