Installing Batteries

This massager requires 4x AA-sized alkaline batteries to operate.

- 1. Remove the cover of the battery compartment.
- Insert 4 AA-sized alkaline batteries into the compartment following the polarity diagram.
- 3. Put the battery compartment cover back on.

Using the Massager

- Once the batteries are installed, use the [Power] switch on the massager to power the massager ON.
- The massager has a high and low setting.
- · Gently press the massager to aching or sore areas.
