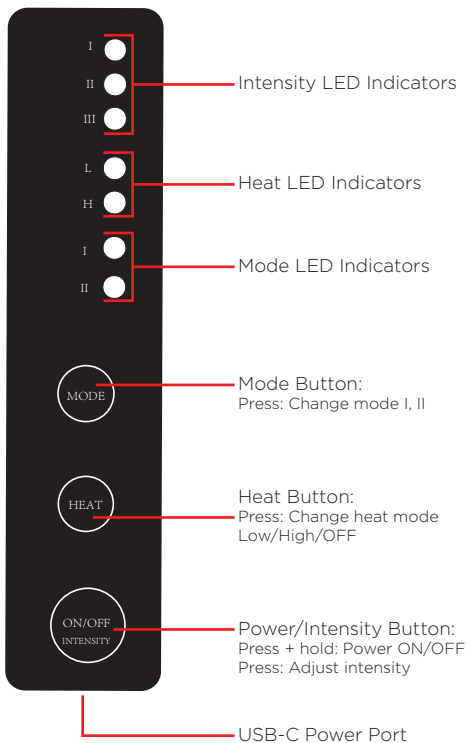

Getting Started

Placement & Setup

1. The massager may be used on the arm or leg. Place on the arm or leg, such as in one of the positions below. The cords exiting the device should be pointed down, or away from you.



Forearm



Calf

2. Secure onto your body by pulling the straps through the slots, and securing the fasteners.
3. Connect to power by plugging the USB-C (smaller) connector of the included power cable into the USB-C port on the bottom of the control panel. Plug the USB (larger) connector into a **5V/1A USB power source**, such as a USB wall adapter (*not included*), and plug into an electrical outlet.

Note: The device is rechargeable and can be used without connection to power after charging.

Powering ON/OFF

- Press + hold the Power/Intensity button to power the massager ON/OFF.
- The mode and intensity LED indicators will indicate when the massager is powered ON.



Adjusting Intensity

Power the massager ON.

- Press the Power/Intensity button to adjust intensity between modes I, II, III.



Adjusting Mode

Power the massager ON.

- Press the Mode button to adjust intensity between modes I, II.
- The two modes are different air compression massaging styles.



Using Heat

Power the massager ON.

- Press the Heat button to switch between heat modes Low (L), High (H) and OFF.



Automatic Shutoff

The massager will automatically shut off after 10 minutes of use.

Cleaning & Storage

Turn off, unplug, and let the massager cool down.

Spot clean with a soft, damp cloth, using no abrasive cleaners.

- Do NOT immerse in water or any type of liquid.
- Do not allow any liquid to come into direct contact with the USB connectors or ports.
- Store in a dry, cool location, away from sources of water, heat or dust. It is best stored in an airtight bag or container (*not included*).
