**Setting Up**

Unzip the battery pouch. Insert 2 new AA-sized batteries (*not included*) into the battery compartment, following the polarity (+/-) diagram in the compartment. Do not mix old and new batteries, or mix different types or brands of battery. Zip the pouch closed.

**Powering ON/OFF**

- Press the [⏻] button on the end of the pillow to power ON.
- Press the [⏻] button again to power OFF.

**Cleaning the Pillow**

Turn off and let cool down. Spot clean the pillow with a soft, damp cloth, using no abrasive cleaners.

- Do NOT immerse in water or any type of liquid.
- Do not allow any liquid to come into direct contact with the battery pack.

## Storing the Pillow

Store the pillow in a dry, cool location, away from sources of water, heat or dust. It is best stored in an airtight bag or container (*not included*).

If you are storing the pillow for an extended period of time, remove the batteries.
