
# Before You Begin...


# Location of Controls



- 1. Remove the cover and inner lid and insert the pin of the supplied power cable into the power jack on the bottom of the diffuser. Insert the other end into a USB power source such as a computer or a **5V USB adapter** (not included) and
- 2. Fill the tank with room temperature water up to the MAX
- 3. Add 2 3 drops (-0.1 0.15 mL) of essential oil. 4. Place the inner lid and cover back on then set the diffuser

plug into an electrical outlet

- on a flat, sturdy surface.
- 5. Press the Mist button on the front of the diffuser to turn ON.



CAUTION: Using more than the recommended amount of oil may cause the diffuser to get clogged and not operate properly.

When finished using, drain any remaining water from the tank, carefully rinse, and let dry. If you would like to more thoroughly clean the diffuser, use a small amount of neutral deterge such as dish soap.

# Using the Diffuser

- $\bullet$  Press the  ${\bf Mist}$  button to turn the diffuser on and diffuse mist continuously until the water tank is empty. The ON LED indicator will light up.

  The diffuser will shut down if there is no water in the tank.
- · Press the Mist button a 2nd time and the diffuser will operate
