

Installing Batteries

- 1. Remove the battery cover from the bottom of the mouse.
- 2. Install 2 new Alkaline batteries into the battery compartment of the mouse, following the polarity (+/-) diagram in the compartment. Do not mix old and new batteries, or mix different brands or types of battery.
- The mouse takes 2 AAA-sized batteries (not included)
- 3. Replace the battery cover back onto the battery compartment.

Plug the included USB receiver into any of the USB ports (Type-A) on the front or back of your computer.
