Setup

Note: Do NOT stand on massager.

Insert the attached USB connector into a USB power port or into a **5V USB adapter** (not included) and plug into a wall socket.

Sit down. Place your legs in the leg warming massager, opening and closing the snaps on the side of the warmer if necessary. Place your feet on the massage pad.

Using the Massager

- **Press and hold** the [⏻] button on the side of the massager to power the massager ON and OFF. The massager will power ON in Heat Only mode, and the [⏻] button will light up **RED**.
- Press the [⏻] button to switch to Massage Only mode. The [⏻] button will light up **BLUE**.
- Press the [⏻] button again to switch to Heat + Massage mode. The [⏻] button will light up **GREEN**.
- Press the [⏻] button a 3rd time to return to Heat Only mode.



Cleaning and Maintenance

Turn the massager OFF, and let cool down. Wipe down the fabric with a damp (NOT wet) cloth or sponge. **SPOT CLEAN ONLY.**

- Do NOT immerse the leg warmer in water.
- Do not allow any liquid or cleaning solutions to come into direct contact with the USB connector.
