Charging the Light

Plug the small connector of the included charging cable into the charging port on the light. Plug the large connector into a USB power port or into a compatible 5V USB adapter and plug into a wall socket.

Setting Up

Clip the selfie light onto your device. The light should grip the device securely.

Using the Selfie Light

Charge the light. Press the **[Power]** button on the selfie light to turn the light ON/OFF and change the brightness setting.
