### Charging the Light

Plug the small connector of the included charging cable into the charging port on the light. Plug the large connector into a USB power source or into a compatible 5V USB adapter (*not included*) and plug into a wall socket.

### Setting Up

Clip the selfie light onto your device with the light facing you. The light should grip the device securely.

### Using the Selfie Light

Charge the light. Press the **[Power]** button on the selfie light to turn the light ON/OFF and change the brightness setting.
