Setting Up the Wireless Charging Pad

Plug the small connector of the included power cable into the power port on the side of the charging pad. Plug the large connector into the USB port on a computer or or a compatible 5V USB adapter (not included) and plug into a wall socket.


on the charging pad will light up **solid** RED to indicate that it is connected

Using the Wireless Charging Pad

The included wireless charging pad can wirelessly charge the case, and any other Qi-compatible device. Check your device's instruction manual to see if it is compatible with the Qi charging standard.

- 1. Set up the wireless charging pad.
- Place the bottom of the case or device in the center of the charging pad as shown.
- 3. An LED indicator on the charging pad will light up **solid BLUE** when it is charging a device. The LED indicator on the bottom of the case will **flash BLUE** while charging and turn solid BLUE when the case is fully charged.

Note: You may need to remove the case on your device to charge. If the device does not begin charging when placed on the wireless charging pad, try repositioning it.



Charging the Case Directly

Plug the small connector of the supplied USB charging cable into the USB charging port on the bottom of the case. Plug the large connector into the USB port on a computer, a USB charging device, or **5V USB adapter** (not included) and plug into a wall socket.

The LED indicator on the bottom of the case will flash BLUE while charging, and turn solid BLUE when the case is fully charged

Charging the Earbuds

Open the lid of the charging case and insert the earbuds into the case's earbud charging ports. The earbuds will automatically begin charging. The earbuds' LED indicators will turn solid RED and the LED indicator on the bottom of the case will turn solid BLUE when the earbuds are charging. When the earbuds are fully charged, th ndicator will turn OFF and the earbuds' LED indicators will turn BLUE for 30 seconds before turning OFF.

NOTE: When the earbuds have less than 5% charge remaining, a voice will be heard and the earbud LED indicators will flash RED every 10 seconds.

Powering ON/OFF
